RECENT DEVELOPMENTS

USPTO to Allow Some Electronic Patent Filings During COVID-19

Due to the COVID-19 pandemic, the USPTO [is set to allow filing](#) of “plant patent applications and follow-on documents via the USPTO patent electronic filing systems until further notice.” Only registered USPTO users will be able to use the USPTO to file any follow-on documents to existing applications in this temporary allowance. It is unclear just how long the USPTO will allow electronic filings of this kind. Justifying the change, the USPTO said it “considers the effects of the COVID-19 outbreak to be an ‘extraordinary situation’ within the meaning of 37 CFR 1.183.”

In Response to Outcry, USPTO Now Masks Registrant Email Address

Earlier this year, the USPTO began requiring an [email address](#) for all applicants and registrants to be included in all trademark filings in an effort to move towards completely paperless operations. Following public outcry over the information being included in the publicly-available trademark database, the Office quickly changed course and is now masking registrant email addresses in its publicly-available documents. However, if a registrant or applicant is unrepresented, their email will still appear in the correspondence tab of the Office’s TSDR pages. This change will help the Office combat the longstanding problem of [scams and solicitations](#) from parties who scrape the USPTO database for targets.

GENERAL NEWS

Trademark Trial and Appeal Board Refuses to Register JUST DREW IT! Trademark

Nike won an opposition action against two New York City individuals seeking to register the trademark JUST DREW IT! in connection with apparel. In refusing registration, the Trademark Trial and Appeal Board found Nike's JUST DO IT mark to be a household name, citing a study calling it "one of the most famous and easily recognized slogans in advertising history." Fame in a trademark action is difficult to establish, requiring extremely wide recognition. This finding, a culmination of an opposition action that began in 2018, demonstrates the strength of the JUST DO IT mark.

This case is Nike Inc. v. Caldwell, Case No. 91240394, in the U.S. Patent and Trademark Office's Trademark Trial and Appeal Board.

New Balance Wins 1.5 Million Judgment in Chinese Court

In a demonstration of China's willingness to protect foreign Intellectual Property, the Shanghai Pudong People's Court awarded New Balance a \$1.54 million judgment after finding Chinese firm New Barlun had used an "N" symbol similar to New Balance's. This is the latest entry in a 16-year saga of disputes between New Balance and New Barlun. This recent victory comes as China drafts an Intellectual Property protection action plan as required in the "phase one" January 2020 Economic Trade Agreement between the U.S. and China.

Australian Leather Requests Pause to Ugg Boots Infringement Verdict

In May of 2019, jurors awarded a \$450,000 verdict to Deckers, the makers of Ugg Boots, finding Australian Leather had willfully infringed Deckers' trademarks. Now, Australian Leather is asking an Illinois federal judge to pause the verdict so as to not bankrupt the company and leave it unable to appeal the case. Australian Leather holds it may be unduly denied its opportunity to overturn the award should they go bankrupt paying it.

This case is Deckers Outdoor Corp. v. Australian Leather Pty. Ltd., 1:16-cv-03676 (N.D. Ill. 2020)

Fleet Feet Hits Back in Nike Ad Fight

On appeal from a December 2019 injunction halting Nike's SPORT CHANGES EVERYTHING ad campaign, retailer Fleet Feet responded to Nike's allegations that the injunction is a restraint on speech. Nike had previously asserted that Fleet Feet had not carried its burden to show irreparable injury. In its April filing, Fleet Feet told the court it "was not required to wait until actual harm occurred before seeking injunctive relief" and asserted that Nike had since abandoned its slogan, rendering the issue moot.

This case is Fleet Feet Inc. v. Nike Inc. et al., 19-2390 (4th Cir. 2020)

Federal Court Rules Nike owns Kawhi Leonard's 'Claw' Logo

An Oregon federal judge has granted Nike's motion for judgment on the pleadings dismissing NBA Finals MVP Kawhi Leonard's case against Nike over ownership of its 'Claw' Logo bearing Leonard's initials. The dispute began when Leonard signed an endorsement deal with Nike competitor New Balance. After the move, Nike conceded that Leonard had provided a rough draft of the logo, but asserted Nike's inside creative team had created the "plainly distinct" final version.

This case is Leonard v. Nike, Inc., 3:19-cv-01586 (D. Or. 2020)

[Berluti SA, et al. v. Berlutishoeoutlet.com, et al.](#), 0:20-cv-60708, Dkt. 1 (S.D. Fla. April 6, 2020). Synopsis: Berluti SA and Louis Vuitton bring a trademark infringement action against a long list of alleged online counterfeiters.

[Shen Ko Tseng v. ACI Int. LLC, et al.](#), 5:20-cv-02694-EJD, Dkt. 1 (N.D. Cal. April 17, 2020). Synopsis: an individual, Shen Ko Tseng, alleges an importer, distributor, and retailer trafficked in footwear infringing on Tseng's purported patent for arrays of lights in childrens' shoes.

[Allbirds, Inc. v. Giesswein Walkwaren AG, et al.](#), 19-cv-05638-BLF, LEXIS 69160 (N.D. Cal. April 20, 2020). Synopsis: The Northern District of California denies defendants' motion to dismiss this trademark infringement action. The Court found defendants had not sufficiently demonstrated fair use and refused to take judicial notice of defendants' use of the term WOOL RUNNERS as descriptive rather than as a trademark.

[Deckers Outdoor Corp. v. Steve Madden, Ltd., et al.](#), 2:20-cv-03670, Dkt. 1 (C.D. Cal. April 21, 2020). Synopsis: Ugg boot maker Deckers Outdoor Corp. brings trade dress infringement, patent infringement, and unfair competition claims against Steve Madden for allegedly infringing on the design of its Fluff Yeah slippers.
