TBMP Changes Correspondence Requirements for TTAB Filings

In June, the USPTO released the 2020 revised version of the Trademark Trial and Appeal Board Manual of Procedure ([TBMP](#)). The updated TBMP brings the TTAB rules in line with earlier rule changes within the Trademark Examining Operation, with respect to foreign-domiciled parties being required to be represented by an attorney licensed in the United States and with the mandatory electronic filing requirements. USPTO Announces Fast-Track Appeals Pilot Program

Fast-Track Appeals Pilot Program is an extension of the Track One Prioritized Examination Program, and aims to expedite resolution of *ex parte* patent appeals before the PTAB. The USPTO anticipates that, under this new program, patent applicants will receive a decision regarding *ex parte* appeals within six months from the date a petition is granted, thereby slashing the wait time by more than half when compared to the current average 14-month wait time. The number of *ex parte* appeals to be reviewed under this new program will be initially limited to a maximum of 500 per fiscal year, or 125 per quarter. Additionally, in order to keep *ex parte* appeals under this program on schedule, an oral hearing will not be rescheduled or relocated once scheduled. Puma Moves to Block Nike from Getting a Trademark Registration for “Footware”

in an effort to block Nike, Inc. from obtaining a trademark registration on their applied for mark “Footware,” Puma SE has filed a notice of opposition with TTAB. Nike filed for the mark following their launch of Adapt, which features a smart shoe platform that uses software and autolacing technology to adapt a sneaker to a user’s foot. in the opposition notice, Puma SE alleges that consumers will understand “footware” as a descriptive term for footwear featuring software. Puma SE notes that they too sell products that combine footwear and software and allege that granting Nike exclusive rights to the term “footware” would prevent competitors from using a descriptive term in the marketplace.

This case is Puma SE v. Nike Inc., ESTTA Tracking No. ESTTA1062684, in the U.S. Patent and Trademark Office’s Trademark Trial and Appeal Board.

Adidas Unsuccessfully Appeals PTAB Loss to Nike

Adidas appealed the PTAB’s decision to uphold two Nike, Inc. patents regarding knitted sneaker technology. the Federal Circuit held that Adidas had standing to appeal the PTAB ruling even though Adidas was not sued over the patents. the Federal Circuit noted that an appellant need not face a specific threat of infringement litigation by the patentee to establish the requisite injury in an appeal from a final written decision in an inter partes review. Nike’s refusal to grant Adidas a covenant not to sue further confirmed Adidas risk of injury was not hypothetical, thus the appeal had standing. Adidas argued that the PTAB erred in finding no motivation to combine the prior art. the Federal Circuit ruled against Adidas noting that substantial evidence supports the Board’s factual findings and thus, the Board did not err in its obviousness analysis. the Federal Circuit affirmed the PTAB’s decision to uphold the two Nike patents.

This case is Adidas AG v. Nike, Inc., No. 2019-1787, 2020 WL 3455802 (Fed. Cir. June 25, 2020)

Dominique Wilkins v. ACC3421, et al.

Synopsis: Dominique Wilkins, a former NBA All-Star player, brings an action against a long list of alleged infringers for unfair competition, false designation of origin, common law trademark infringement and misappropriation of Wilkins’ right of publicity with respect to his name.

Amazon.com Inc. et al. v. Kaitlyn Pan Group LLC et al.

Synopsis: Amazon and Valentino S.p.A. files a joint lawsuit against Kaitlyn Pan Group LLC, alleging breach of contract of Amazon’s Business Solutions Agreement, unfair competition, and infringement of Valentino’s trademarks and patents regarding their Rockstud shoes.

Jezipn Licensing, LLC v. Bebe Stores, Inc., et al.
