## RECENT DEVELOPMENTS

### USPTO has Set a Date for the Implementation of the Adjusted Patent Fee Schedule

On August 3, 2020 the USPTO issued a final rule that will alter patent fees for the first time in almost three years. the summary of the fiscal year (FY) 2020 final patent fee rule noted that the fee adjustments are necessary to “adjust to increasing costs and to provide necessary resources for Patent operations, including implementing the USPTO 2018-2022 Strategic Plan.” the final rule increases most of the impacted fees by about five percent. Additionally, the final rule discontinued three patent service fees and one OED service fee. the new patent fee schedule will be effective on October 2, 2020, except for the surcharge for non-DOCX filings, which will be effective on January 1, 2022. According to the USPTO, the state of the US economy, the operational needs of the agency, and the comments and advice received from the public during the 60-day comment period were all considerations in the decision to delay the effective date of the new patent fee schedule. ## GENERAL NEWS

### Dispute over Champion Branded Shoes in the International Market

Hanes Brands, Inc. and HBI Branded Apparel Enterprises, LLC, hereinafter collectively referred to as “Hanes”, filed suit against Keds, LLC and SR Holdings, LLC, hereinafter collectively referred to as “Keds.” in the complaint, Hanes asserts that in 1987 they first agreed to share the “Champion” trademark with Keds for footwear in the U.S., Canada, and Puerto Rico. Champion asserts that under the terms of the agreement, Keds’ use of the CHAMPION brand was limited to “casual street and play time shoes” while Hanes’ use was to be for athletic shoes. the agreement did not allocate rights outside of the U.S., Canada, and Puerto Rico, and permitted each party to pursue trademark protection in other jurisdictions. Hanes alleges that Keds’ use of the “Champion” trademark expanded over time into territories where it does not have a registered trademark and/or where Hanes has superior rights to the “Champion” mark. Hanes further alleges that Keds has failed to engage in the promised renegotiation of the parties’ license agreement. Hanes is seeking action for trademark infringement, unfair competition and false association, trademark dilution, breach of contract, breach of the implied covenant of good faith and fair dealing, unfair and deceptive trade practices.

## Nike & Adidas Evade Athletic-Shoe Soles Infringement Claim

The Federal Circuit affirmed a North Carolina Middle District Court's grant of summary judgment that Nike, Inc. and Adidas America, Inc. did not infringe an Akeva LLC patent that covered improvements to athletic shoe soles. the Federal Circuit agreed that the Akeva patent clearly disclaims and therefore does not disclose a shoe with a conventional fixed rear sole. the Federal Circuit also upheld the District Court's finding that the chain of priority was broken thereby preventing the Akeva continuation applications covering a fixed sole to be used in this case, as they were preceded by Nike's accused shoes.

*This case is Akeva LLC v. Nike Inc. et al., Case No. 19-2249, in the U.S. Court of Appeals for the Federal Circuit.*
