Ocean Freight Rates Have Been Turbulent At Best









Background & Context

- Post payment audit finds the errors well after the fact when it's too late to do anything about it
- Industry average error rates via post payment audit typically trend in the 20-30% range


- Pre payment audit finds the errors as they happen so the providers see the mistakes and can resolve the issues
- Average error rates via the AcuAudit platform typically trend in the 8-12% range because the issues are found & fixed
- In \$ terms the errors typically trend in the range of 60% over and 40% under





Q1 2022 Ocean Audit Observations

- In Q1 2022 WE saw error rates trending in the 25-35% range
 3x typical/expected
- In Q1 2022 the AVERAGE \$ error (when rated incorrectly) for Carriers was greater than \$3k and substantially higher for Forwarders (15-20x what we'd typically expect!)
- In \$ terms the errors trend flipped with roughly 70% under and 30% over
- Why?
 - Spot Rates!
 - Systems and processes couldn't keep up with how fast rates increased









Q1 2023 Ocean Audit Observations When the Provider was Wrong

Туре	% of Invoices Over Charged	Average \$ Over Charge	% of Error \$\$ Over Charged
Carrier	53%	\$1,800	77%
Forwarder	66%	\$3,409	81%

Туре	% of Invoices Under Charged	Average \$ Under Charge	% of Error \$\$ Under Charged
Carrier	47%	\$(588)	23%
Forwarder	34%	\$(1,496)	19%










Q1 2023 Ocean Audit Observations Average for ALL Invoices

Туре	% of Invoices Rated Incorrectly	Average Gross (ABS) Error \$ Value	Average Net Error \$ Value
Carrier	15.59	\$191.17	\$104.36
Forwarder	10.44	\$287.62	\$180.52

- In Q1 2023 WE saw error rates trending back closer to the typical range of 8-12%
- In Q1 2023 WE saw the average \$ amount of the errors drop substantially but it's still significantly higher than typical
